GOVERNING POLICE

- Canada has one of the best systems of police governance in the world
- Contrast with the U.S. where governance is:
 - Inadequate
 - 2. Extremely varied
- Governance critical in maintaining public trust and legitimacy
 - Contrast 'blue lives matter' in U.S. with agenda outlined by the CACP at their recent conference on the relationship between police and indigenous people.

TWO REACTIONS TO THIS

- The silliness over operations and policy has to stop (Andrew Graham)
- Board responsibilities must be clarified before composition, training, etc. can begin to be addressed. To do otherwise would be rudderless. (Fred Kaustinen).

GOVERNANCE QUESTIONS

- Can part-time board members deal with the burden of accountability they face?
- Can a board do more than rubber stamp choices?
- How can boards govern without intruding into the CEO's responsibilities?
- How can a board know what it needs to know without being overwhelmed with information?

POLICY GOVERNANCE MODEL

- How can a board, on behalf of shareholders, see to it that a business achieves what it should (normally in terms of shareholder value) and avoids unacceptable solutions and actions?
- Basic assumption that board represents owners.
 Thus it has to exercise its authority and to govern.
- In policing, the 'owner' is the public. Peel established municipal policing based on the notion that the police are the public. Boards ensure this is done.
- Boards represent the public not Council, not the police service, and not special interest groups.

POLICY GOVERNANCE MODEL

 Fundamental dilemma – board must control the CEO, but also must give the CEO the freedom to act

THE CONTRADICTION OF GOVERNANCE

- Police independence
- Accountability and governance



DEALING WITH THE CONTRADICTION -CARVER

- How to do this?
 - By controlling 'ends' in an affirmative, prescriptive way
 - By controlling 'means' in a limiting proscriptive way.
 - Don't tell CEO how to do the job, but rather how not to do it
 - This gives the chief the necessary managerial freedom, but also puts boundaries around it

POLICY GOVERNANCE MODEL - ENDS

- What ends do you want for your police service?
- You will get very different behaviours from police officers if you:
 - Direct the chief to increase revenues from traffic tickets by \$1.5 million
 - Direct the chief to reduce traffic collisions by
 25%

POLICY GOVERNANCE MODEL - MEANS

• What activities by management would be unacceptable even if they worked? (Carver)




